

# Presentation of board members in Nepa AB (publ)

The nomination committee, Dan Foreman (chairman of the board), Ashkan Senobari (appointed by Hanover Investors), Ulrich Boyer (on his own mandate), Marcus Wahlberg (appointed by Elementa Management), and Björn Nordenborg (on his own mandate), together represents approximately 57 percent of the votes in the Company.
